




CONSTRUCTION

The VEX-WPCR Series is constructed of high-impact, corrosion-resistant thermoplastic. The UV-resistant faceplates are protected by high-abuse, clear polycarbonate which is recessed into the housing. The unit comes standard with an external LED status indicator and test switch.

Stencil letters are 6" high with 3/4" stroke.

ILLUMINATION

Illumination of the VEX-WPCR Series is achieved with high-output, long-lasting red or green LEDs exceeding UL 924 requirements for brightness and uniformity. An exclusive color matched diffuser eliminates hot spots and striations, providing optimal light output.

EMERGENCY LIGHTS

Two fully adjustable LED lamps allow for accurate positioning and reduced maintenance. Each emergency lamp consumes 1.17 Watts.

ELECTRICAL

Input

Dual-voltage input 120 or 277VAC @ 60Hz.

Nickel Cadmium Battery - NiCad (Standard)

Exitronix nickel cadmium batteries are maintenance-free.

Nickel Metal Hydride Battery - NiMH (Remote Capable)

Exitronix nickel metal hydride batteries are maintenance-free.

Brownout Circuit

Brownout circuit monitors the line voltage. As the line voltage sags and can no longer illuminate the exit sign to meet UL 924 visibility test, the emergency circuit will turn on to supply a portion or all the power to illuminate the sign for a minimum of 90 minutes until the line voltage is restored.


Overload and Short Circuit Protection

The overload monitoring system is a Solid-state circuit which monitors the lamp load and disconnects from the battery should an overload or short circuit occur. The overload current protection eliminates the need for fuses or circuit breakers for the DC load.

Test Button

The test button is easy to locate and provides manual verification of the transfer circuit and emergency lamps.
