Keystone Technologies warrants that the lamps listed below will be free of defects in material and workmanship and comply with their respective published specifications, from the date of installation, for the time periods outlined below and subject to the terms and conditions herein.

## **FLUORESCENT LAMPS**

These warranties apply only to lamps that are operated a maximum of 4,000 hours per year, on burning cycles of (3) hours or more per start for instant and rapid start ballasts, and (15) minutes or more per start for program start ballasts. Occupancy sensor application only allowed in conjunction with program start ballasts (15 minute/start minimum.) If lamps fail to operate for the warranty period, Keystone will, at its sole discretion, provide a free replacement lamp (but no labor allowance) or issue a credit for future purchase.
