LITETRONICS WARRANTS EACH LITETRONICS LED PRODUCT TO BE FREE FROM DEFECTS OF MATERIAL AND WORKMANSHIP, AND TO OPERATE WITHIN THE MANUFACTURER'S RANGE OF SPECIFICATIONS COMMENCING FROM THE DATE OF PURCHASE AND CONTINUING FOR A PERIOD OF 5 YEARS ("WARRANTY PERIOD") OR 50,000 HOURS BURN TIME, WHICHEVER COMES FIRST, SUBJECT TO THE TERMS AND CONDITIONS SPECIFIED BELOW. IF THE PURCHASE DATE IS NOT KNOWN, AVAILABLE, OR VERIFIABLE, THEN THE WARRANTY PERIOD WILL BE DEEMED TO COMMENCE ON THE DATE OF MANUFACTURE. TERMS AND CONDITIONS

This warranty is invalid when the Product is not used in accordance with Litetronics' specifications, or used in violation of any applicable standard, code, or instructions for use in installations, including installation instructions contained in the latest National Electrical Code (NEC), the Standards for Safety of Underwriters Laboratory, Inc. (UL), Standards for the American National Standards Institute (ANSI) or, in Canada, the Canadian Standards Association (CSA). This warranty will not apply in any of the events of: (1) Products returned in a condition demonstrating abnormal use or stress, including without limitation, under/over voltage, sprayed with water, exposed to weather or excessive heat. (2) the invoice is not paid in full according to the invoice terms; or (3) the returned Product has been used outside the recommended operating conditions; The recommended operating conditions for the Litetronics LED Product is for use in an application wherein the ambient operating temperature in location T(a) is between 32°F and 122°F.
